2. Who can apply for the program?

To be eligible for the program, you have to be an experienced crop farmer and have the following resources:

- An ample piece of farming land that is close to a water source
- A cropping area that is accessible by road
- Be between the ages of 25 to 50
- Be physically fit
- Provide a general medical report
